2. General Terms and Conditions

- a) Interested persons ("the Applicants" hereafter) may obtain the complete set of EOI documents containing detailed terms and conditions, eligibility criteria, application form & procedure and Terms Of Reference (TORs), latest by 21-01-2021 from Administration Department at 12th floor, PRC Towers, Karachi during office hours (9:30 am to 5:00 pm). The bidding document can also be downloaded from www.pakre.org.pk.
- b) The expression of Interest ("the Bids" hereafter) shall be prepared in accordance with the instructions given in this document.
- c) The sealed bids (separately marked as technical and financial) along with the
- d) documents/information as per RFP should reach at the below mentioned address on or before 21/01/2021 at 11:00 am. Technical bids will be opened on the same day at 11:30 am.
- e) Method of selection will be Single <u>Stage Two Envelop</u> of procurement specified in PPRA Rules 2004 and allied regulations, thereof.
- f) After scrutiny and technical evaluation of the received proposals, only technically qualified bidders will be invited for the opening of Financial Proposal. Venue and timing will be communicated to the technically qualified bidders in advance.
- g) Bids received after the due date, conditional and incomplete bids will be rejected.
- h) The bidder or one authorized representative shall attend the tender opening, if desired.
- i) The bidder should be registered with PMDC(now PMC), Copy of valid registration duly issued byPMDC(or PMC) should be attached application(bid).
- j) Details of Litigation if any, and Certificate of not being black listed by any government organization should be enclosed.
- k) PRCL will enter into an agreement the successful (lowest evaluated) bidder.
- PRCL shall disqualify bidder(s) if it finds, at any time, that the information submitted by the bidder concerning its qualification was false and materially



inaccurate. Such bidders will be blacklisted.

m) PRCL reserves the right to reject any or all bids at any time prior to the acceptance of a bid or proposal as per PPRA rules.

Submission of Proposals

3.1.1 Technical Proposal

The technical proposal containing (*Schedule-A*) enclosed with this document must be submitted along with copies of all required documents mentioned therein. The technical Proposal must be kept in a sealed envelope. The envelop shall clearly be marked as "TECHINAL PROPOSAL" along with tender number.

3.1.2. Financial Proposal

The financial Proposal (*Schedule-B*) indicating the quoted price in figures as well as in words must be kept in a **SEPARATE SEALED ENVELOPE**. The envelop shall clearly be marked as "FINANCIAL PROPOSAL" along with tender number.

3.2. Both envelops of financial and technical proposal shall be kept yet in another properly sealed envelope clearly marked *"Expression of Interest for Medical Attendant"* shall be dropped in drobox placed at 14th floor of PRC towers latest by 21-01-2021.

4. Eligibility Criteria

- 4.1. The applicant must have MBBS degree from a collage/university/institute duly recognized by Higher Education of Pakistan and be a qualified professional as General Practitioner with 3 years post qualification experience in a public/private hospital.
- 4.2. The applicant must have valid registration with PMDC/PMC.

6. Disqualification

6.1.1 Proposals are liable to be rejected if: -

- a) Proposals are found to be conditional or incomplete in any respect;
- b) Received later than the appointed / fixed, date and a time;
- c) There is any deviation from the Instructions to contained in this document;
- d) Multiple rates are quoted;
- e) Proposals (Financial / Technical) containing the unauthenticated amendments/corrections / overwriting);
- f) If the validity of Proposal is not quoted as required;
- g) Proposal made through Fax / E-mail / Telex.

7. Terms of Reference/Duties and Responsibilities

- a) To visit PRCL head office daily for 4 hours and scrutinize medical files, bills panel pharmacies, laboratories, hospitals.
- b) To check, verify and countersign the claims of employees and their families for medical reimbursements from PRCL;
- c) To attend patients for consultations as envisaged in PRCL Medical Regulations, and to issue reference letters and/or any other advice as contained under treatment clause of PRCL Medical Regulations;
- d) To carry out medical examination and to review medical reports of all newly recruited employees;
- e) To refer patients to panel hospitals/approved specialists; as the case may be;



- f) To conduct random visits to employees or their families at panel hospitals where they are admitted and liaise with panel hospitals' authorities for best possible treatment of the patient(s);
- g) To provide technical assistance to Administration Department of PRCL during the performance of their functions;
- h) To assist PRCL in implementing medical regulations for medical attendance and to perform any other task/function as may be assigned by PRCL management;

<u>Note:</u> for the purpose of this clause "patient" means PRCL existing employees & their family and PRCL retired employees & their dependents as defined in PRCL Medical Attendance Regulations, 1969.

8. Cost of Preparation of EOI and Liability

The bidder (Applicant) shall bear all costs associated with the preparation and submission of the EOI document. PRCL will, in no case, be responsible or liable for these costs, or have any other liability to any Applicant, regardless of the conduct or outcome of the EOI process. PRCL shall have no obligation to any Applicant to reimburse any costs incurred in preparing a response to this EOI

9. Technical and Financial Evaluation:

9.1. PRCL shall evaluate the eligible Applicant based on the eligibility parameters and evaluation criteria prescribed herein after. Anything not mentioned in this document regarding the EOI process shall be governed by the prevailing Public Procurement Rules and Regulations issued by the PPRA.

9.2. Technical Evaluation

- 9.2.1. Technical Proposals will be opened in the presence of bidder's representatives who wish to attend the Bidding process. The technical bids will be evaluated and minimum points for a bid being technically qualified is 65 points out of 100 points
- 9.2.2. The technical proposal shall be evaluated as per following:

9.3 Financial Evaluation

- 9.1. Financial proposal (to be submitted on prescribed form enclosed herewith as *Schedule-B*) will be evaluated on Least Cost Method of Selection.
- 9.2. The financial proposal must be inclusive of all taxes applicable in Pakistan including out of pocket expenses.
- 9.3. Financial proposals of only technically qualified applicants will be opened during an interview, date and time of interview will only be communicated to technically qualified applicants.
- 9.4. Financial bids of technically unsuccessful/unqualified applicants will be returned unopened.
- 9.5. As per rules rule 31 of PPRA Rules 2004 no change/modification in financial proposal will be accepted/allowed once the same has been opened publicly.



10. Validity of Proposal

The Proposals validity period shall be 90 days from the last date for submission of the Tender.

11. Payment/Remuneration

- 11.1. At the end of each month of agreement period, Payment will be made on as per bio-metric attendance. Deduction shall be made in case of late coming, i-e late arrival for three consecutive days shall be treated as one absence.
- 11.2. No Payment for absence day(s) will be made.
- 11.3. Payment will be made after deduction of all applicable taxes.
- 11.4. No separate remuneration/POL will be admissible, However in case of visits to PRCL NZO Office, Lahore TA/DA equivalent to TA/DA rate(s) of Manager grade of PRCL will be paid with due approval of CEO, PRCL.

12. Award Criteria

The lowest evaluated applicant will be awarded the tender under the evaluation criteria spelled out in para 9 of this document.

13. Arbitration

In case of any difference or dispute arising between the parties relating to the present bid or during the contract period, shall be referred to resolution to the Chief Executive Officer of PRCL or his duly authorized nominee whose decision shall be final and binding on both the parties and cannot be challenged in any court of law.
